

MINUTES FROM EXTRAORDINARY GENERAL MEETING

FOR

NORWAY ROYAL SALMON ASA

(org. no. 864 234 232)

On 28 October 2022, an extraordinary general meeting of NORWAY ROYAL SALMON ASA was held electronically. The meeting started at 10:00 and ended at 10:10.

Agenda:

- Item 1** Election of a chairperson and a person to countersign the minutes of the General Meeting together with the chairperson
- Item 2** Approval of the notice and proposed agenda
- Item 3** Removal of deadline for merger with SalMar ASA

The chairman of the board, Paal E. Johnsen, opened the meeting and registered the shareholders present.

According to the list, a total of 36,861,861 shares and 36,861,861 votes were represented. Thus, excluding the company's own shares, approximately 85 % of the share capital was represented.

The chairman of the board, Paal E. Johnsen, was present together with CEO Charles Høstlund.

An overview of the shareholders present is attached to these minutes as Appendix 1.

ITEM 1 ELECTION OF A CHAIRPERSON AND A PERSON TO COUNTERSIGN THE MINUTES OF THE GENERAL MEETING TOGETHER WITH THE CHAIRPERSON

The chairman of the board, Paal E. Johnsen was elected as chairperson of the meeting.

Filip Truyen was elected to countersign the minutes together with the chairperson.

The item was unanimously approved.

ITEM 2 APPROVAL OF THE NOTICE AND PROPOSED AGENDA

There were no objections to the notice or the agenda for the extraordinary general meeting, dated 5 October 2022.

The general meeting was declared as lawfully convened.

The item was unanimously approved.

ITEM 3 REMOVAL OF DEADLINE FOR MERGER WITH SALMAR ASA

The chairperson of the meeting referred to the merger plan prepared by the board of directors of Norway Royal Salmon ASA and SalMar ASA dated 30 May 2022, as adopted by the general meetings of the respective companies on 30 June 2022.

The chairperson of the meeting then referred to the board's proposed resolution in the notice of the extraordinary general meeting of 5 October 2022.

The processes of obtaining the necessary approvals for the merger from the relevant authorities, including the European Commission, have taken longer than expected when the merger plan was entered into. The background for the board's proposal is to give the respective companies sufficient time to obtain these approvals.

A vote was then taken in which shareholders who votes for the board's proposal votes "For", while shareholders who vote against the board's proposal votes "Against".

The vote showed the following result:

Votes for: 36,820,226


Votes against: 0

It was then determined that the general meeting had made the following resolution with a sufficient majority:

Section 8, second paragraph in the merger plan dated 30 May 2022 for the merger between Norway Royal Salmon ASA and SalMar ASA is removed in its entirety, and replaced by a new section 8, second paragraph which reads as follows:

"The merger shall be carried out as soon as practically and legally possible after the conditions in (a) - (c) have been met. Otherwise, the merger will lapse. The same applies if it is clear that any of the conditions will not be met or waived. None of the parties are obliged to waive conditions for the merger."

There were no other items to be discussed. The chairperson of the meeting thanked everyone for attending.
